Septic/Well Refunds: Refunds on new construction will be refunded all of the septage surcharge and fee (if paid) in addition to the below permit refund schedule

- Refund requested prior to any field work – 100% Refund - \$20.00 Processing Fee
- Involves field work with no report written – 50% Refund - \$20.00 Processing Fee
- Final report or permit has been completed – No Refund

Permit Renewal: 50% of Original Permit Fee (not including septage surcharge) Renews for a max of 2 years from original expiration date. See Renewal policy.

Soil Borings: Septic Permits and Site Survey fees include up to three (3) soil test borings. Test borings in excess of three (3) shall be calculated at \$25.00 for each additional boring.

** As of June 1, 2004 an additional surcharge fee has been assessed to all new onsite septic permits within Grand Traverse County towards the future expansions of the septage treatment facility. This fee is collected on behalf of the Department of Public Works.
